

Cookie Policy

1. Introduction

1.1. Our website, https://www.carelearninganddevelopment.com (hereinafter: 'the website') uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). Cookies are also placed by third parties we have engaged. In the document below we inform you about the use of cookies on our website.

2. What are cookies?

2.1. A cookie is a small simple file that is sent along with pages of this website and stored by your browser on the hard drive of your computer or another device. The information stored therein may be returned to our servers or to the servers of the relevant third parties during a subsequent visit.

3. What are scripts?

3.1. A script is a piece of programme code that is used to make our website function properly and interactively. This code is executed on our server or on your device.

4. What is a web beacon?

4.1. A web beacon (or a pixel tag) is a small, invisible piece of text or image on a website that is used to monitor traffic on a website. To do this, various data about you is stored using web beacons.

5. Third parties

5.1. We have made agreements about the use of cookies with other companies that place cookies. However, we cannot guarantee that these third parties handle your personal data in a reliable or secure manner. Parties such as Google are to be considered as independent data controllers within the meaning of the United Kingdom-GDPR. We recommend that you read the privacy statements of these companies.

6. Cookies

- **6.1.** Technical or functional cookies
 - **6.1.1.** Some cookies ensure that certain parts of the website work properly and that your user preferences remain known. By placing functional cookies, we make it easier for you to visit our website. This way, you do not need to repeatedly enter the same information when visiting our website and, for example, the items remain in your shopping cart until you have paid. We may place these cookies without your consent.
- **6.2.** Analytical cookies
 - **6.2.1.** We do not use analytical cookies on this website.
- **6.3.** Advertising cookies
 - **6.3.1.** We do not use any advertising cookies on this website.
- **6.4.** Social media buttons
 - **6.4.1.** On our website we do not use social media buttons to promote web pages or share them on social networks.

8. Your rights with respect to personal data

 - **8.1.3.** Right to rectification: you have the right to supplement, correct, have deleted or blocked your personal data whenever you wish.
 - **8.1.4.** If you give us your consent to process your data, you have the right to revoke that consent and to have your personal data deleted.
 - **8.1.5.** Right to transfer your data: you have the right to request all your personal data from the controller and transfer it in its entirety to another controller.
 - **8.1.6.** Right to object: you may object to the processing of your data. We comply with this unless there are justified grounds for processing.

If you have a complaint about how we handle your data, we would like to hear from you, but you also have the right to submit a complaint to the supervisory authority (the Information Commissioner's Office (ICO).
